

Privacy Policy

Collection of your personal information

We do not collect any personal information about you unless you voluntarily provide it to us. You may be required to provide certain personal information to us when you elect to use certain products or services available on the site. These may include: (A) register registering for an account on our site; (B) entering information into any forms on www.zaazi.net; (D) sending us an email message. Use of your personal information
